CALENDAR DESCRIPTION

Students in this course will develop essential employment skills through an introduction to local, sustainable, small-scale food production. They will work collaboratively to practice soil stewardship, grow, preserve, prepare, and sell food. Students will practice their learning, communication, and social skills through exploring and promoting related topics such as food literacy, sustainability, food preservation, and the stewardship of Indigenous ecosystems.

- Use communication and decision-making skills to initiate tasks relevant to current work within food plant production and basic garden maintenance crew
- Work safely and effectively in a food production/entry-level horticulture setting

- Professionally interact with peers, teachers, supervisors, community partners, and customers to grow, prepare, and sell food plants
- Plan a food production garden in an assigned location

- Within each student's ability and means, research and communicate about topics related to gardening, horticulture and/or food production
- identify personal strengths generalizable to entry level work of interest to the student
