# **EVALUATION OF LEARNING**

This course focuses on developing critical thinking skills to assess a range of readings. Students write and edit expository paragraphs using a variety of punctuation and grammatical structures. Students explore lifelong learning practices: goal setting, problem solving and internet searching. Students will build a portfolio of their work to be used as an evaluative tool in the assessment of their progress in the course.

This is a self-paced course. Students have the flexibility to follow an individually-adaptable timeline to complete the learning outcomes and assignments. The course is a combination of 6 online, blended and/or inperson hours per week with an expectation of studying another 4 hours per week.
