CALENDAR DESCRIPTION

Students in this course will be provided practice and instruction in critical reading and be able to demonstrate creative and critical thinking. Students will practice and receive instruction in the planning, writing, and revising of paragraphs and essays, to prepare them for college writing. Students will also learn to gather, evaluate, synthesize, and organize information into a research paper as well as deliver a research-based oral presentation. This course prepares students for post-secondary academic English courses.

Note: ENGL 092 combined with ENGL 094 or ENGL 095 is equivalent to Provincial English 12.

PREREQUISITE(S): One of: C in English 11, C in ENGL 070

- A. Critical and Creative Thinking
 - evaluate argument for validity, reliability, currency, and objectivity
 - recognize elements of clear communication
 - demonstrate organizational thought processes to solve problems

 - record, organize and store information read, heard or viewed
 - support a position by citing specific details from what has been read, heard or viewed
 - explore diverse perspectives to develop or modify one's point of view
 - assess one's knowledge and use of language
 - assess information for completeness, accuracy, currency, relevance, balance or perspectives and bias
 - analyze different presentations of the same information to reconsider positions
 - assess ways in which language reflects and influences values and behaviour

B. Reading and Reference

- evaluate the effectiveness of one's own and others' written material using criteria that include the
 following: plain language; coherence and organization; consistency in the application of usage
 conventions; relevance to argument of supporting evidence and examples; appropriateness to
 intended purpose and audience; attention to detail
- summarize, make inferences, draw conclusions and critically evaluate
- paraphrase main ideas in written material
- distinguish between implicit and explicit messages
- apply prior knowledge and experience to assist in understanding new material
- use a variety of strategies and sources to gather and evaluate information, including print sources, library resources and the Internet
- interpret details and conclusions from information presented in a variety of print and graphic formats, including electronic formats

C. Written Communication

- plan and write a variety of types of paragraphs and essays
- edit own work fully for coherence and accuracy
- monitor spelling, grammar, mechanics and syntax using appropriate techniques and resources as required, including electronic technology
- write effectively, adjusting for audience, purpose and situation to inform, persuade, and interact in formal and informal situations
- organize information and ideas to clarify thinking and achieve the desired effect
- understand and avoid plagiarism
- produce writing on demand (e.g. essays, exams)
- gather, evaluate, synthesize, and organize information into a research paper of approximately 1500 words using an appropriate documentation style (e.g. APA, MLA or Chicago)

D. Speaking and Listening Skills

- interact effectively in formal or informal situations
- adjust the speaking style to suit audience, purpose and situation
- give and respond to feedback during oral presentations
- use effective presentation aids to enhance communications
- deliver a research-based oral presentation to inform or persuade and respond effectively to feedback
- demonstrate a critical understanding of arguments
