- Produce writing under exam or exam-like conditions;
- Write clear, concise, effective prose, and know how to identify as well as correct common mechanical and grammatical errors.
- Evaluate secondary sources and integrate where applicable;
- Write persuasive arguments in scholarly, academic essay format, using MLA documentation.

- Use print and electronic resources effectively and efficiently.

- Late submissions: 10% is docked for each day an assignment is late. Assignments more than a week late will not be accepted and will receive an F grade.
- Class absences/assignment extensions will only be granted without penalty given certain extenuating circumstances (for example, college related activities, religious

- holidays, etc.). These must be declared in advance of the absence/request for extension.
