#### CALENDAR DESCRIPTION

This course will provide the student with an introductory exposure to financial mathematics and financial concepts. Topics include: determination of interest rates, the time value of money, annuities, financing alternatives and capital budgeting. The course is a foundation course in any subsequent study of business finance.

## COURSE LEARNING OUTCOMES / OBJECTIVES

Upon successful completion of this course, students will be able to:

- Calculate the time-value of money and use this information to solve for unknown payments, final payments, and equivalent payment streams.
- Use both simple and compound interest to calculate interest rate, maturity value, present value, and time to maturity for items such as credit cards, student loans, treasury bills, commercial paper and promissory notes.
- Convert between different nominal interest rates to compare investments.
- Distinguish among several types of annuities and choose the appropriate formula to solve business-related word problems, such as, retirement planning, mortgage calculations, amortization, personal credit repayments and refinancing.
- Describe bonds and calculate bond purchase prices, bond market quotes and yield to maturity to make sound investment decisions.
- Choose between sinking funds or amortization to calculate loan repayment schedules.
- Use net present value and internal rate of return to determine the most profitable course of action among alternatives.
- Identify and select appropriate financing sources for starting and expanding businesses
- Explain Cash Flows as it relates to financing needs

**Zoom Check-In**: You will be asked to connect with me over zoom for a small 5-minute discussion of your current progress in the class and any issues you may have with the material or the format of the course. You will have about 5 meetings during the semester.

Homework: You will have to complete these formative assessments each week. The assessments will be a random assortment of questions similar to what you may be asked in the exam. The questions will have randomly generated numbers (for the most part), there will be both a written solution and video solution to the homework. The homework is meant to be formative. If you attempt the homework and provide an answer for each question, you will be awarded full points for the homework. You will get an unlimited number of attempts on the homework.

**Quizzes:** The quizzes will be practice for the exam. They are a low stake mean for you to measure your progress in the class up to this point. They will include some examples questions from previous examinations.

**Midterms and Final**: You will have 2 midterm examination and a final examination. The midterms are not cumulative. The Final is cumulative. There will be strict requirements that will be communicated clearly in the first week with regards to how the exam will be taken. These will be online with the use of integrity advocate. The exams are exactly 2 hours long.

Chat GPT and other AI tools. During this course, you are going to be required to complete a number of written assignments. Can you use AI to complete this!? Maybe! If you choose to use AI for one of your written assignments, you must DISCLOSE that you have used it and indicate which portion of the text was prepared by AI versus prepared by you. Within your report, you must include a discussion on WHY you used chat GPT, how it helped you, and what areas it left out. Did you make any edits to what it gave you? If I find that chat GPT has been used and not disclosed, even when permitted, academic integrity penalties will be applied. AI is not appropriate in response to debrief questions or reflections on self-learning, and cannot be used in exams.
