PREREQUISITE(S): A grade of "C" in Principles of Math 11 or Applications of Math 12 or a "C+" in Math072. In addition, it is expected that students are familiar with the operation of their calculators, and that they will participate in course activities and stay current with their homework.

COURSE LEARNING OUTCOMES / OBJECTIVES

Upon successful completion of this course, students will be able to:

1. Calculate the time-value of money and use this information to solve for unknown payments, final payments and equivalent payment streams.

- 2. Use both simple and compound interest to calculate interest rate, maturity value, present value and time to maturity for items such as credit cards, student loans, treasury bills, commercial paper and promissory notes.
- 3. Convert between different nominal interest rates to compare investments.
- 4. Distinguish among several types of annuities and choose the appropriate formula to solve business-related word problems, such as, retirement planning, mortgage calculations, amortization, personal credit repayments and refinancing.
- 5. Describe bonds and calculate bond purchase prices, bond market quotes and yield to maturity to make sound investment decisions.
- 6. Choose between sinking funds or amortization to calculate loan repayment schedules.
- 7. Use net present value and internal rate of return to determine the most profitable course of action among alternatives.

REQUIRED MATERIALS & RECOMMENDED PREPARATION / INFORMATION

Text: Business Mathematics in Canada – Jerome & Worswick, 10th edition (online e-text)

Other: D2L will be used to provide additional online materials and coursework. Texas Instruments BAII+ financial calculator. This calculator is highly recommended. This course will utilize PowerPoint and, as needed, Blackboard Collaborate (the link can be found within D2L under the Navigation Bar heading "Collaborate"). Quizzes: There will be a number of online quizzes during the term. You will complete the quizzes on your own time. For each quiz, you will be allowed up to three attempts with your highest score counting toward your grade.

Of all the quizzes, your lowest quiz score will be dropped and the remaining quizzes will count equally toward your final grade. This allows you to miss a quiz when sick and still not impact your final grade.

Exams: There are two midterm exams and a final exam for this course.

All rough work is required to be sent to the instructor via email immediately (within 20 minutes) following the exam. The rough work must follow the supplied template (available on D2L). Failure to send legible rough work on time this may result in a zero grade for the exam and possible disciplinary action. Students are allowed one 8 $\frac{1}{2}$ x 11" sheet (both sides) to place applicable formulae. No question examples are permitted on this sheet, and it must be handwritten. In addition, you will need to bring your calculator (the TI BAII+ as detailed above).

Cell phones, watches, music players, translators or similar devices are not permitted during exams. Students found with these devices will receive a score of zero on the exam. Internet access (other than D2L) is not allowed during the exam.
