This course focuses on the goals and functions of financial management, the acquisition of shortterm and long-term funds, and the evaluation of investment performance. Particular attention is devoted to current assets, capital structure, financial instruments, cash budgeting, leasing, and financial analysis.

- 8. Demonstrate and explain decisions relating to dividend policy and retained earnings within a corporate environment
- 9. Explain the use of rights and warrants in financial management
