Topics include capital budgeting under uncertainty, long term sources of funds, capital structure, dividend policy, financing and investment decisions, derivatives, risk management and strategic issues in finance.

- 4. To evaluate corporate dividend policy plus compare and contrast stock dividends, stock splits and share repurchases
- 5. To analyse special financing and investment decisions including mergers and acquisitions, and leveraged buyouts
- 6. To assess treasury risk management, including interest rate risk, foreign exchange risk, commodity price risk and international trade financing
- 7. To evaluate and analyse financial derviatives including futures, forwards, options and swaps.

**Check-in:** The check-ins are 5 minutes meeting on Zoom. I will provide many different times at the beginning of the semester when I'll be available for these meetings. **Homework:** You will have to complete these formative assessments each week. The assessments will be a random assortment of questions like what you may be asked in the examination. The questions will have video solutions. The worksheet is meant to be formative. If you attempt the homework, you will be granted full mark. The homework is due on Friday at 11:30PM. You will get as many attempts as you want for the homework.

**Quizzes:** The quizzes will be practice for the exams. They are a low stake mean for you to measure your progress in the class up to this point. You only have one attempt per quiz. You are expected to complete textbook questions, homework questions etc. to practice for the quiz.

**Interview Examination:** This evaluation will be a 10 to 15 minutes interview with your instructor. The instructor will provide you with a broad question in advance, and you will have to answer the question during the interview. If you answer the question incorrectly, the instructor will provide you with leading questions and prompts to guide you to the correct solution.

**Midterms and Final**: You will have a midterm examination and a final examination. The midterms are not cumulative. The Final is cumulative.
