Generally, there will be one assignment completed per lecture topic. Lab assignments will focus on applied learning in the area of geography related to the course. Podcasts will be related to the topic of Canadian geography and will be assessed by online quiz or discussion. There will be one term project for the course. Details will be provided prior to the midterm.

The lab/podcast assignment due date will be at the beginning the subsequent lab period, unless otherwise instructed. Late assignments will not be accepted after I have returned them marked. Anyone cheating or copying work will receive a mark of zero on the assignment.
