COURSE GUIDELINES & EXPECTATIONS

There are multiple components to this course:

<u>Lectures</u>: I am choosing to structure this course along four themes: the physical characteristics of the province, the primary economic sectors and associated politics, the cultural past and present, and the social norms that are uniquely British Columbian. Each week there will be a traditional two-hour lecture, normally on Mondays.

<u>Assignments</u>: There are ten assignments in the course all of which focus on specific facets of each of the province. You will be given a week to complete a series of questions that pertain to a topic or a locale. Computer access will be required for most of the assignments as you will be referring you to a variety of websites and data sources.

<u>Pick-a-Town-Any-Town Project</u>: You will be asked to choose a town in British Columbia and prepare a report summarizing its attributes. One photo will be required (more are encouraged), and the rest of the text will address the physical, economic, political, and social personality of your town.

<u>Readings</u>: In this course, I would like to introduce you to the scholarship found in <u>BC Studies: The British Columbia Quarterly</u>. I will ask you to read five articles over the course of the term – most of them long and involved – that present scholarly research and perspectives on British Columbia. In the spirit of reconciliation, I have chosen readings that explore the broad theme of "Whose Land Is It?", the title of the opening reading for the term and a present-day issue for all of us. These readings will be examinable, and I will ask you to synthesize and comment on them through external software.

<u>Tests</u>: There will be three tests this term, the first one on **Wednesday**, **October 5**th, the second on **Wednesday**, **November 9**th, and the third on **Wednesday**, **December 7**th. Each test will have a selection of short-answer, true or false, multiple-choice, and short essay-type questions.

There will be no scheduled final exam in the College exam week for this course.
