Students are introduced to the conceptual foundations of resource and environmental management, emphasizing geographic understanding of natural resource systems within environmental, social, economic, and policy frameworks in Canada. Students will explore issues such as Indigenous rights and relationships to land, internationalization, globalization, and trade, and examine strategies and tools such as adaptive management, ecosystem-based management, impact assessment, and conflict resolution.

COURSE GUIDELINES & EXPECTATIONS

There are multiple components to this course.

<u>Lectures</u>: This class is designed in three parts. Part One is an introduction to Resource and Environmental Management with an emphasis on Canada. Part Two looks at approaches to Environmental Management and Part 3 focuses on practices. Lectures for this class are on Tuesdays from 9:30 to 11:20.

<u>Labs Assignments</u>: There are ten lab assignments in this course and are quite varied in their design. They are a mixture of discussions, response papers, workshops, and projects that are designed to augment course material. Labs for this class are on Thursdays from 9:30 to 11:20. Computer access will be required for most of the assignments as you will be referencing a variety of websites and data sources.

<u>Term Project</u>: There will be a term project due the last week of class. You will create a multi-sensory presentation of an Environmental and Resource Management Issue. More information about this term project will be given later.

<u>Tests</u>: There will be three theory tests this term. The first one is on Tuesday, February 13th, the second one is on Tuesday, March 19th, and the third one during the Camosun College Exam week. Each test will have a selection of short-answer, multiple choice, and short essay type questions.

<u>Readings:</u> In this course, you will read five peer-reviewed journal articles. Most of them will be long and involved. These readings will be examinable, and I will ask you to synthesize and comment on them through external software.
