#### **CALENDAR DESCRIPTION**

This course provides students with an overview of the knowledge and skills needed to assess acute and persistent mental health and substance use challenges. Applying a holistic, culturally informed and strength-based collaborative approach to assessment, students evaluate and apply various assessment tools, conduct intake interviews, and synthesize multiple data sources to develop a written biopsychosocial assessment and create a plan matching services to the individual's recovery goals and needs.

- 1. Conduct a psycho-social history and synthesize multiple sources of information to create a biopsychosocial assessment and personalized recovery plan
- 2. Utilize knowledge of a range of assessment tools to screen for mental illness and substance use as well as to evaluate the psychosocial functioning of the individual and their family
- 3. Assess and address suicide and other psychosocial risks according to individual needs, organizational protocols, and expectations
- 4. Apply an evidence-informed conceptual framework to facilitate planning and intervention
- 5. Apply culturally sensitive and diversity-informed frameworks to assessment and recovery planning

#### **EVALUATION OF LEARNING**

#### APPLIED LEARNING

Students will engage in experiential activities, self-reflective exercises, and simulated learning opportunities to develop and practice skills such as conducting narrative-style assessment interviews, applying a cultural formulation interview, and creating a written biopsychosocial assessment and recovery plan.

#### **INDIGENIZATION**

In this course, we will focus on assessment tools and counselling strategies that are congruent with Indigenous ways of being and are culturally relevant. For example, introducing students to narrative-style interviewing, the cultural formulation interview, and using culturally relevant screening tools.

#### **COURSE GUIDELINES & EXPECTATIONS**

This is an interactive course that uses a variety of teaching/learning strategies, lectures, discussion, cooperative learning, and guest speakers.

Please arrive for planned classes and meetings on time and be prepared to participate in discussions and activities. The course is planned as a continuum for building the skills and knowledge required to meet the competencies for CFCS graduates. Students are required to contact the instructor in advance if they are unable to attend planned classes.

To pass this course, students must satisfactorily complete all assignments and learning activities with a minimum grade of C for each assignment. Written assignments must be submitted via D2L. File names should include your name for easy reference.

Written assignments must be typed and double spaced and follow APA guidelines. Pay particular attention to page numbering and headers, line spacing, font and font size, the citation of source material, and cover-page format. Spelling, grammar, and presentation of the material will be taken into consideration when assignments are graded.

All assignments are to be submitted on designated due dates. In some circumstances, students may arrange with the instructor for an extension of an assignment before the due date. Marks will be deducted (5% per day) if prior arrangements have not been made with the instructor.

- Respectful behavior toward classmates and instructor
