CALENDAR DESCRIPTION

Students will study introductory quantitative, qualitative, and mixed-method research approaches to health and human performance. Students will focus on methods and design; measurement issues; statistical analysis; interpretation of literature; and analytical procedures used for research in sport, health, and exercise science.

- Explain the nature and purpose of research as it relates to sport, health, exercise science and wellness.
- Explain the underlying assumptions with both qualitative and quantitative research and be able to discuss the characteristics of both approaches.
- Describe the methodologies of both qualitative and quantitative approaches.
- Discuss the ethical issues and requirements in doing human research.
- Explain a range of data gathering techniques.
- Apply statistical procedures to data.
- Demonstrate the ability to read a variety of research approaches and respond to the research in a critically constructive fashion.
- Demonstrate the ability to communicate research in an oral, written and visual manner.
- Formulate research hypotheses based on review of the research literature and other sources of information.
- Develop a research design, proposal and project.

COURSE GUIDELINES & EXPECTATIONS

<u>ATTENDANCE</u>: Students are expected to review lectures and participate in class discussions. While abbreviated lecture notes and other resources are easily accessible at any time through D2L, it is impossible to duplicate the discussion, activities, and interactions that take place in the classroom.

If a student is absent, *the student* is responsible for any information missed regarding lecture material, group discussions, exam format/content and dates. Students should obtain any missed information from their peers before scheduling an appointment with the Instructor during their office hours.

LATE ASSIGNMENTS: A 10% deduction per day will be taken for late assignments (<u>up to a maximum of five</u> <u>days</u>). If a student expects to be absent on the day an assignment is due, arrangements must be made to hand in the assignment early or to have it submitted in class (or to D2L) the day it's due. Research posters and poster presentations must be completed by the last scheduled day for presentations; a grade of ZERO will be given for all incomplete assignments after the final day of scheduled presentations.

<u>ACADEMIC WRITING</u>: Papers and / or assignments that are deemed unacceptable* by the Instructor will be returned and receive an automatic 10% deduction on the grading. Papers and / or assignments will receive a 10% per day deduction thereafter, to a maximum of five days. *Reasons that an Instructor may deem an item unacceptable include but are not limited to the following: grammar; spelling; content; punctuation and inappropriate referencing / citations.

<u>ARRIVING LATE TO EXAMS</u>: If a student arrives late to an exam after the exam has begun and no other student as left the room, then the student may be allowed to write the exam with the time remaining (note no extra time will be given). If a student arrives late to an exam and another student has already left the room, then the student may not be allowed to write the exam and a grade of zero will be granted.

<u>MISSING EXAMS OR OTHER ASSESSMENTS</u>: If a student is unable to complete a quiz or course assessment through no fault of their own for medical or other reasons, this must be discussed with the instructor in advance, or within 24 hours of the missed evaluation. Examples of valid reasons for missing an exam or evaluation include, but are not limited to, medical emergencies or illness; death in the immediate family (death certificate required); an intercollegiate trip (note from the Athletic Director, Head Therapist, or Coach required) and other significant personal occurrences. If a student who is absent has not made arrangements with the Instructor in advance or within 24 hours of the missed assessment, he or she will be unable to make up the missed evaluation.
