Students will explore the role of adventure in the diverse range of outdoor programs and services that facilitate health promotion, educational, recreational, and developmental outcomes. Students will engage with place-based and Indigenous ways of being and knowing as a means to increase and diversify their knowledges and capacities, develop interpersonal skills, and explore leadership in outdoor contexts

- Apply in outdoor settings the multiple elements required to plan and carry out a safe and educational/developmental one-day outdoor experience including hazard management and group management strategies
- Exhibit responsible and ethical leadership to support positive group interactions, social and cultural diversity, and the achievement of group goals
- Critically engage with concepts related to human-nature relationships and describe how these relate to
 the health and wellbeing of individuals and the wider community in the context of activity/health
 promotion

COURSE GUIDELINES & EXPECTATIONS

Teaching modes and locations

This course involves a combination of face-to-face and online work through D2L. We will spend as much time as possible outdoors. At other times we will be based in the classroom. Please pay careful attention to the information given for each class.

When off-campus we will meet in parks local to the Victoria area. Please be sure to read the information provided on when and where to meet. You should *always* check the weather forecast carefully so that you are able to come suitably prepared to be able to care for yourself and able to contribute to both your own and others' learning. You should bring a notepad and pen as you would when on campus.

Attendance

To get the most out of this course, students are expected to attend all classes and be on time. It is your responsibility to acquire all information given during a class missed, including notes, hand-outs, changed exam dates, etc.

Equipment and clothing

For *every* class, whether we are scheduled to be on-campus or off-campus, you should bring clothing and footwear suitable to protect you from rough ground, rain, cold, or heat. You should follow any advice given on what to bring with you – please do not assume that you will not need it. If you are lacking anything then please speak to me to find a solution to the problem.

At times we will divide the class into two or more groups. This allows us to remain within sectoral best practice guidelines regarding instructor/student ratios when necessary. Please refer to D2L to see which group you are in. You will need to take very careful note of which group you are in and information on D2L so that you can be in the right place at the right time and prepared to take part in the class.

Due Dates, late submissions, and exam procedures

The due dates are established in accordance with the course and term duration. The purpose of the due dates is to help both you and I to get the assignments done so that they can be assessed in a timely manner. Just as you need time to complete the assignments, I need enough time to grade them. As such, the due dates are fixed (unless you have an approved academic accommodation through CAL) and it is expected that students will hand in assignments on time. Assignment marks, comments, and feedback will be returned to students in a timely manner, usually within 1-3 weeks, depending on the length of the assignment.

All assignments must be handed in by the time indicated (on the assignment, or on D2L). Late assignments may be graded but marks equivalent to 10% of the total value of the assignment will be deducted for each day, inclusive of days on the weekend, past the deadline. If assignments have already been marked and returned, a late assignment will not be accepted. Assignments will not be accepted that are late more than three days, inclusive of days over the weekend.

All exams must be written at the scheduled times with the exception of students requiring an accommodation by CAL.

It is understood that emergency circumstances do occur (e.g. severe illness or family emergency); for such circumstances accommodation may be offered at the discretion of the instructor, provided the student: a) notifies the instructor in advance of the exam or submission deadline (not after), and b) provides documented evidence of the circumstance (e.g. medical certificate).

Study Habits

Good and regular study habits are essential to do well in this course. The expectation is that you will reflect on physical learning activities and supplement your learning through applying theoretical concepts to the experiences. These concepts will be gained from class lectures, discussions, and your own wider reading. You should plan on a weekly minimum of 6 hours outside of scheduled class time for the completion of readings, assignments and for general studying. Joining a study group can help make this more achievable.

Lecture presentations will be uploaded to the course website. These should be used as a study guide, not as your sole source of information. You will need to write down additional key words for examples and explanations given during lecture and review text and videos to support your understanding.
