CALENDAR DESCRIPTION

This course introduces students to the duties and responsibilities of a legal office assistant working in family law in British Columbia. Topics covered include: specialized legal terminology; Federal and Provincial Statute Law and Regulations; Forms and Rules of Court for BC's Provincial and Supreme Court matters; Alternative Dispute Resolution; Family Law Agreements; Preparing, filing and maintaining client files; Confidentiality and client management and current family law specific technology.

PREREQUISITE(S), CO-REQUISITE(S), EXCLUSION(S):

One of: C in LGL 150 or C in BUS 276 - Must be completed prior to taking this course.

COURSE LEARNING OUTCOMES / OBJECTIVES

1. Practice confidentiality and demonstrate an awareness of ethical responsibilities in the completion of legal documents and correspondence in family law matters.
2. Apply knowledge of contract law to typical family law agreements.
3. Describe the role of Alternative Dispute Resolution used in family law proceedings.
4. Locate and use relevant Federal and Provincial Statutes, Rules and forms.

5. Manage all aspects of client files from commencement to conclusion of a family law proceeding.
6. Produce documents required in BC Provincial Court family law matters.
7. Produce documents required in BC Supreme Court family law matters.
8. Demonstrate knowledge of editing and proofreading skills, using precision and speed when completing legal documents and correspondence in family law matters.
9. Apply critical thinking and problem-solving skills when completing legal documents and correspondence in family law matters.
10. Use current technology specific to family law proceedings to prepare documents in family law proceedings.

a) Discussions – 30% of final grade:

Students will participate in three discussions, worth 10% each, as follows:

- Discussion #1 is about the Provincial Court of BC. This discussion is available starting at 8:00am on January 27 and is due by 10:00pm on January 29.
- Discussion #2 is about the Supreme Court of BC. This discussion is available starting at 8:00am on February 24 and is due by 10:00pm on February 26.
- Discussion #3 is about Indigenous child welfare. This discussion is available starting at 8:00am on April 7 and is due by 10:00pm on April 9.

b) Theory Quizzes – 20% of final grade:

Students will do seven theory quizzes. All quizzes are weighted equally and count (collectively) for 20% of the course marks. Students have a maximum of 45 minutes to complete each quiz, and all quizzes are available from 8:00am until 10:00pm on the following dates:

- Quiz #1 – January 16
- Quiz #2 – January 23
- Quiz #3 – February 6
- Quiz #4 – March 6
- Quiz #5 – March 13
- Quiz #6 – March 20

c) Practical Assignments – 50% of final grade:

Students will complete two assignments, worth 25% each, as follows:

- Practical Assignment #1 asks students to create documents used in provincial court family law practice. This assignment is available starting at 8:00am on February 10 and is due by 10:00pm on February 13.
- Practical Assignment #2 asks students to create documents relevant to family law practice in the supreme court of BC. This assignment is available starting at 8:00am on March 31 and is due by 10:00pm on April 3.
