CALENDAR DESCRIPTION

Restricted to students in **Massage Therapy**

Students will be introduced to manual applications of massage therapy. Students will study the physiological effects, indications, and safety considerations for various Swedish massage techniques. Students will develop their palpation skills and learn proper biomechanics, hygiene practices, patient handling, and draping techniques in massage therapy.

COURSE LEARNING OUTCOMES / OBJECTIVES

At the completion of this course, students will be able to:

- Demonstrate knowledge of indications, safety considerations, effects, and outcomes of various Swedish massage techniques used for relaxation.
- Apply and modify various Swedish massage techniques into treatment based on patient/client history, presentation, and response.
- Utilize standard hygiene practices and apply standard precautions for infection control.
- Identify common biomechanical and postural risks for massage therapists.
- Apply biomechanical and postural skills to preserve therapist health.
- Drape/undrape patients appropriately for treatment.
- Conduct oneself professionally by maintaining appropriate grooming, dress, and hygiene.
- Identify the origins of the practice of using touch as a healing method in historical practice and the general differences between Eastern and Western massage philosophies.

COURSE GUIDELINES & EXPECTATIONS

Students participate in role-playing activities to practice skills on each other. Please be aware that learning what the human body feels like in a healthy condition is important when it comes to recognizing unhealthy or injured states. In the course of learning to do assessments and treatments, students will need to be palpating other students on a regular basis.

Students will maintain optimum levels of safe behavior (personal hygiene, decontamination of personal protective equipment, use of proper body mechanics, etc.) with a minimization of potential for disease transmission.

Students must come **appropriately dressed** to allow for hands on application / demonstration of assessment and treatment techniques.

Low cut shirts, pants / shorts that expose underwear, and flip flop sandals are *NOT* acceptable dress for labs.

Students that do not come prepared to actively participate (appropriate dress, textbooks, etc) may be asked to leave.

Late Assignments are not accepted. Extensions will be granted if they are submitted PRIOR to the deadline.
