CALENDAR DESCRIPTION

Students explore appropriate treatment methods for cancer, dermatological, connective tissue, endocrine, cardiovascular, and female reproduction disorders. Students will study pregnancy, labor and delivery, infant and breast massage treatments. Students will apply theoretical knowledge and various treatment techniques with an emphasis on safe and effective treatment.
