## CALENDAR DESCRIPTION

This course provides the foundation for the application of mechanical theory by Weapon Engineering (WEng) System Maintainer. Topics include principles of stress analysis, journal and anti-friction bearings, shaft arrangements, gearing and machine construction.

- Describe components of the machine design process.
- Explain the principles of the application of stress analysis (including safety factors).
- Calculate stress and strain in shafts and other mechanical systems.
- Explain the principles of journal bearings.
- Select journal bearings based on system requirements.
- Explain the principles of anti-friction (roller element) bearings.
- Compare the aspects of anti-friction and journal bearings.
- Explain the principles of various shaft arrangements.
- Explain the principles of gearing.
- Explain the principles of machine construction.
- Compare belt and chain drives.
- Compare various fasteners.
