#### **CALENDAR DESCRIPTION**

Fluid properties (density, compressibility, viscosity), absolute pressure and gauge pressure will be detailed. Fluid dynamic theory will be examined, including: laminar and turbulent flows, general energy equations, continuity, and fluid flow measurements. Hydraulic system design including, hydraulic fluids, pumps, motors, control valves, flow and pressure control, accumulators, actuators and hydraulic circuits will be covered.
