#### **COURSE GUIDELINES & EXPECTATIONS**

Additional reading materials and assignment instructions are posted to the content on D2L. Students are expected to read through the materials posted to D2L and refer to this information as needed.

The Clinical Liaison will determine the minimum and maximum number of unassisted competencies required to successfully complete this course. Students who complete the required number of unassisted competencies will be eligible for full marks in this category. Students who were unable to achieve the required number of unassisted competencies may be eligible for remediation/extra clinical hours. If a student was unable to obtain unassisted competencies due to lack of exposure in required exams (due to clinic bookings, no-shows, absences, etc.), the student may be eligible for remediation, and the amount will be decided by the Clinical Liaison. If a student is unable to obtain the required competencies with adequate exposure to the required exams, the student may require a learning plan and/or remediation, as decided by the Clinical Liaison. Failure to successfully complete the required number of clinical skills may result in the student receiving an incomplete grade affecting their ability to use this course as a pre or corequisite. This may result in the student being unable to progress in the program.

Image Reviews: Students will be required to meet with their clinical liaison periodically throughout the term to randomly review images and discuss interesting cases. The clinical liaison will coordinate times for these reviews to take place. Students will be assessed on professionalism, receptiveness to constructive feedback and general participation in the image review process. Failure to actively participate in image reviews and/or demonstration of non-professional behaviours may result in students not achieving a full mark for this section. Repeated participation or professionalism concerns may result in a student being assessed a zero (0) in this course.
