CALENDAR DESCRIPTION

This course explores advanced principles of harmony in diatonic music. Vertical and horizontal structures are worked and studied simultaneously. Emphasis is on strong music writing skills supported by an ability to spontaneously create harmony through improvisation.

COURSE LEARNING OUTCOMES / OBJECTIVES

Upon completion of this course a student will be able to:

1. Improvise a melody of up to 16 measures in a diatonic key in response to a given harmonization or head motive, and capture the completed work in short, open, or closed score.
2. Improvise an SATB harmonization effecting modulation, using accepted principles of voice-leading in the style of J. S. Bach, and capture the harmonization in both open and closed score.
3. Demonstrate the function of all triadic constructions up to the 13th within a diatonic key and of individual pitches therein, by composing effective progressions in a major or minor key and annotating them both in Roman numeral and figured notation and in lead-sheet and root-quality chord notation.
4. Identify and correctly resolve appearances of non-harmonic tones in personal compositions and in analysis of pre-existing compositions.
5. Effect modulation to or tonicization of closely-related diatonic keys.
6. Analyze and extrapolate compositional methodologies from simple dance, song, and variation forms.

IMPORTANT: A passing grade of C or better must be earned in this course, Tonal Harmony 2 (MUSC 113), in order to continue next Fall Term with the subsequent course in the Harmony/Theory sequence (MUSC 212 or 216). Since Harmony is a co-requisite to Aural Skills, a passing grade of C or better must be earned in BOTH this course AND Aural Skills 2 (MUSC 115) in order to continue next Fall Term with the subsequent course in the Aural Skills sequence (MUSC 214 or 218). **A grade of D or F in this course will prevent registration in the continuation of BOTH Harmony and Aural Skills**, and will need to be improved to a grade of C or better by retaking it in the subsequent academic year.

COURSE GUIDELINES & EXPECTATIONS

- A. Classroom time, 3 hours per week; Estimated out-of-class time, 3 hours per week minimum provided student attends ALL classes. The amount of time spent on this course may vary from student to student.
- B. Use the Weekly Schedule chart in the Course Schedule section above to stay on track. For each week of the term, class topics, textbook chapters, and assessment due dates are provided in the chart. The following is an overview of the class organization (subject to change): Tuesdays will focus on wrapping up questions from the previous week, then beginning new weekly material and concepts that will appear on the new homework assignment distributed in the next Thursday class and due in the following week on Thursday; Thursdays will be spent finishing weekly material started in the previous class. Students must **be prepared for each class** by reading, PRIOR to class, the chapter(s) listed in the Weekly Schedule chart.
- C. Starting in Week 3, **weekly homework** assignments will be due in class on Thursdays. These assignments will often involve accessing the course website in D2L and the online portal to the textbook. The readability of each assignment you hand in will count into its grade. This includes your handwriting and the correctness of your notation. Students must only submit their own original work; submitting other classmates' assignments on their behalf is not allowed. Periodic **quizzes** (unannounced) will occur at the beginning of class (don't be late!). Attendance and participation are mandatory in all class sessions, as this is a course that depends on synthesizing new concepts with in-class practice.

- D. The **midterm exam** will be given in Week 8 and will test your knowledge of all the material covered since the beginning of the term. The **final composition** project will be a larger compositional assignment given at least two weeks early and due in Week 14 with an in-class performance. The **final exam** may occur any time within the final exam period (April 14-23). All students must be present for the final exam; DO NOT make travel plans that overlap with any part of the exam period. Examination schedules are posted on the post-secondary bulletin board at the VCM by late February.
- E. Attendance is taken at the beginning of each class, and it is your responsibility to notify (email) the instructor each time you are absent. **Each unexcused absence after the first three** will count as a 4-percent deduction to the participation portion of your grade. **Late homework** that has not been granted a deadline extension WILL be accepted with a penalty of 2 percentage points each day an assignment is late, up to a maximum of 30 percentage points deducted. There are no make-ups for missed quizzes or exams and no extensions of homework deadlines **unless your absence is excused AND notice was given PRIOR to class**. Absences may be excused for illness, emergency, or participation in institution-sponsored events when appropriate documentation, if requested, is promptly forwarded to the instructor. In the case of prolonged illness, documentation is required from a doctor (or certified healthcare professional) that includes a clear statement of WHAT you could not do and WHEN you could not do it (e.g., "Student was bedridden from March 5-10," or "Student will not be able to use right hand for two weeks, March 1-15"). It is not necessary to disclose the reason for your illness. Upon approval of your doctor's note, accommodations within reason will be made to reschedule missed assessments or grant extensions on due dates.
- F. Do not bring noise-making devices to class. If you must, turn them OFF (preferred) or be sure your silent mode is truly silent. Extraneous beeps, rings, and buzzes are disrespectful to your classmates and to the instructor. Noisy food is also prohibited in the classroom.
