CALENDAR DESCRIPTION

Students learn fundamental skills of computer music using current software for audio programming. Focus will be on developing interactive computer instrument units that employ MIDI, digital synthesis and musique concrète techniques to realize unique sounds appropriate for sound design or performance settings.

COURSE GUIDELINES & EXPECTATIONS

- A. The average amount of time spent working on materials for this course is 2 hours per week. The weekly schedule in the Course Schedule section, above, outlines the biweekly modules of content that are to be completed in order. For each pair of weeks in the term, topics and assessment due dates are provided.
- B. The Evaluation of Learning section, above, outlines the basis of student assessment. The **participation** portion of your grade consists of eight (8) assessments in total: six (6) class discussions, and two (2) online self-assessment quizzes. The **exercises** portion of your grade consists of three (3) written listening exercises. The **homework** portion of your grade consists of two (2) hands-on assignments. The **project** portion of your grade consists of one (1) final course composition project. Assessments within each category (participation, exercises, homework, and project) are weighted equally.
- C. In order to receive full credit for each of the graded assessments, you must submit them by their respective due dates and times. In the event you do not meet a submission deadline and you have not been given an

extension (see Part D below), I will accept your late work with penalty. Points will be deducted for **each day** an assignment is late (1 point per day, up to a maximum of 30 deducted). Please do your best to submit your work as soon as you have completed it, even if the deadline has passed.

- D. Since this online course is asynchronous (no scheduled class meetings), missing class for holidays or illness is not a concern. You may, however, experience illness that prevents you from meeting a submission deadline. In order to receive an extension in this case, contact the instructor before the deadline and, if requested, forward documentation to the instructor from a doctor (or certified healthcare professional) as soon as possible, preferably before the deadline passes. This documentation is required to include a clear statement of WHAT you could not do and WHEN you could not do it (e.g., "Student was bedridden from October 5-7," or "Student will not be able to use right hand for two weeks, October 1-15"). It is not necessary to disclose the reason for your illness. Upon approval of your request and/or doctor's note, accommodations within reason will be made to help you complete missed work. Note: It is your responsibility to be aware of assessment deadlines and to pace your weekly progress so that you are able to meet these deadlines. **Please contact the instructor as soon as you anticipate that you might miss a submission deadline for any reason.**
