# **Course Description**

### **Course Description:**

Learners will integrate health sciences and disciplinary knowledge to develop care plans for evolving case studies in perioperative and acute medical situations. Learners will develop skills in prioritizing nursing assessment, interventions, and monitoring for safe, competent nursing practice. Evolving case studies involve select psychomotor skills incorporating clinical judgement, prioritization, technologies, and documentation. Learners will contextualize evidence in relation to RN clinical decision-making, supporting evidence-informed nursing practice. Learners will continue to examine the concepts of ethics and informed consent, health promotion, and Indigenous ways of knowing within various case studies.

# Course Guidelines & Expectations

#### **Lab Expectations and Rules**

The labs are heavily used. The listed expectations and rules will make the labs run smoother for everyone.

- The lab must be treated and maintained like a hospital nursing unit.
- Students must adhere to the clinical attire and dress codes identified in the HHS and the program Handbooks.
- Dolls, beds, bedside tables, and medication carts must be left clean, tidy, and free of garbage at the end of each lab.
- At the end of each lab, the teacher basket will only contain items for reuse. Do not place garbage in the teacher baskets.
- Do not "borrow" materials from other teacher baskets. Extra supplies are primarily located on the marked cart and secondarily on the room storage shelves. Instructors can alert lab staff if supplies are needed.
- Please re-use and recycle when possible. Lab staff will advise what materials can be recycled or returned for reuse. Place All SHARPS in the sharps containers.
- Items intended for sharing across lab groups are to be replaced neatly on the appropriate shelves.
- Absolutely NO Food or Drink is permitted in the labs, with the exception of water in a sealed container. Water containers must be kept in the center of the room, away from the bedside.
- When supplies are running low, please notify the instructor who can then notify the lab staff.

Thank you for your cooperation in the above listed rules and expectations.

#### **Guidelines for Clinical Practice**

Learners must demonstrate competence and be approved by the lab instructor for each skill before being able to perform the skill in future nursing practice courses. If a learner misses a lab class, it is

the learner's responsibility to study the theory and to practice the missed skill. Students who miss a lab (skill) are required to arrange a time to demonstrate competence in the skill and be approved by the lab instructor. Students have until the end of the exam period to demonstrate the skill, otherwise their grade for the lab course will be an F.

When working as an LPN, you are not permitted to perform any skills we review in class, unless they are a part of your LPN scope of practice. For any skills outside of your LPN scope, you will have the opportunity to practice in N290. You may also integrate them into your independent practice once you are a registered nurse.

To honor BCCNM professional standards, the Health Professions and Occupations Act, and our legal affiliation agreements with health authorities, students cannot practice skills and assessments in the nursing practice areas until they have learned the theory and practiced that skill or assessment in the nursing lab.

## Additional Information

#### **Supplies for Lab**

Supplies will be provided to students either weekly or at the commencement of a module, in the form of a kit. Kits are to be used during multiple weeks until the module is complete. Learners are responsible for keeping their kits and returning with their kits each class. Forgotten supplies will not be replaced by lab staff, resulting in missed in class practice opportunities.

#### Open Lab

Learners are encouraged to access Open Lab throughout the semester to practice psychomotor skills. Recommended practice time is twice a week, with a duration of fifteen-sixty minutes. Repetitive focused practiced is essential to prevent skill decay. Research has demonstrated that most skills appear to fall below the competency level in 2-4 months (Gonzalez and Sole, 2014).
