Doing readings before class will be extremely helpful; a "skim" will work nicely. You can then reread after class. We will, together, work on subsets of the (voluminous!) exercises provided by the book. Work done during Seminar will involve text exercises or items which I supply. Take-home work will involve the same sources. You are definitely invited (and encouraged) to do more of the exercises in the text or to go over items again which we covered in class. You might, then, email me about them, discuss them during office hours with me, or – of course – bring them up during class.

THERE WILL BE NO REWRITES OF ASSIGNMENTS. Unexcused late work will not be accepted for a grade/score, but I will be willing to mark it with comments such that the learning opportunity is not missed. (An excuse for late work will need to be "official" – such as medical or emergency, and most definitely not things along the lines of cats chewing up homework or the beauty of the day! If you know, in advance, that there is a major life event which will prevent you from handing in work, please discuss it with me before the fact and we may be able to work around the event/date.)
