#### **COURSE GUIDELINES & EXPECTATIONS**

- 1. Please know that regular attendance to both lectures and seminars is important for this class. Classes will provide context for the technical instruction in the text. Work will be assigned in class and some assignments will be completed in class.
- 2. Course Work.

Coursework consists primarily of the following: studying the text, attending lectures and seminars, participation, weekly quizzes on D2L, weekly assignments (usually written arguments), argument comprehension. D2L will give students two attempts at each quiz. Weekly assignments will be done and/or submitted for comments in the seminar and returned to the student the following week.

Students are required to assemble and submit two packages of their course work, one in mid-October and one at the end of November. Note that these are not intended to be big writing assignments. The assignment is to submit a package of already completed work, with three samples selected for emphasis in grading. A brief explanation of why the specific examples are chosen will accompany a proposed grade. Students will meet with me soon after the package is submitted so we can determine together if the work matches the proposed grade or if the grade needs to be revised upward or downward.
