Generally speaking, I don't mind (and may encourage) use of LLM GenAls (e.g., ChatGPT, Grammarly, Gemini, Siri, Claude) for constructive purposes. We'll discuss more in class, and before major assignments & assessments. Any time you are in any doubt about the permissibility of relying on Al: notify & document your use. This goes a long way to establishing good-faith mistakes, if your usage was in fact not permitted. (Most Als keep records of sessions; you should know how to access those to show your prof that your use was authentic and not deceptively intended.)
