2. Intended Learning Outcomes

(If any changes are made to this part, then the Approved Course Description must also be changed and sent through the approval process.)

- 1. Upon completion of the course the student will be able to:
- Apply techniques of vector algebra to solve problems where vectors sum to zero or calculate resultant vectors.
- 3. Perform coordinate system conversions.
- 4. Demonstrate operations of vector addition and subtraction using graphical, vector component and unit vector techniques.
- Calculate and interpret scalar product and vector products. Solve problems involving particle kinematics and dynamics for translational motion with non-constant force. Apply kinematic equations to analyze motion of objects subject to constant acceleration. Use calculus to analyze motion of objects with non-constant acceleration.
- 6. Use vector components to analyze motion in two and three dimensions.
- 7. Solve problems for objects undergoing uniform and non-uniform circular motion.
- 8. State and apply Newton's Laws to analyze systems subject to concurrent forces including friction, inclines and connected objects.
- 9. Analyze the rotational motion of rigid bodies.
- 10. Calculate the center-of-mass and moment-of-inertia for uniform objects including the parallel-axis theorem.
- 11. Perform calculations and answer conceptual questions using torques. Solve equilibrium problems for non-concurrent forces.
- 12. Define the rotational kinematic quantities; transform between linear and rotational quantities. Use the rotational form of Newton's 2nd Law to solve dynamics problems.
- 13. Apply translational and rotational conditions of mechanical equilibrium.
- 14. Use work-energy theorem and other conservation laws to solve applied problems.
- 15. Solve problems involving work by constant and non-constant forces in two and three dimensions. Calculate work, energy and power for rotational systems.
- 16. Perform calculations utilizing the conservation of momentum of isolated systems for elastic and

- inelastic collisions.
- 17. Perform calculations utilizing the conservation of angular momentum for rotating systems.
- 18. Apply concepts of dynamics, work and energy to analyze charged particles in electric and magnetic fields. a. Calculate electric fields, forces, potential and potential energy for point charges and simple charge distributions.
- 19. Perform calculations for charged particles moving in uniform electric and magnetic fields; describe their motion and practical applications.
- 20. Solve problems for multi-branch direct current circuits using Ohm's Laws and Kirchhoff's Rules.
- 21. Examine the validity of key physical principles through the use of practical experimental techniques. a. Assemble experimental apparatus using written instructions.
- 22. Observe and record data including sources of error and estimate the range of uncertainty in results. Interpret meaning of experimental results in the context of the experimental objectives. Write scientific reports in correct format.

B. Temporary Grades

Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
