# **EVALUATION OF LEARNING**

Marks will be determined based on the following work:

DESCRIPTION		WEIGHTING
Course Tour Bonus Quiz: At the start the semester, students will be asked to complete the Course Tour Bonus Quiz. The quiz will be worth up to 1%.		1% (bonus)
Reading Quizzes (RQ): 1% each; 10% total		
With each new chapter or reading students will be asked to complete an online multiple-choice quiz in the course D2L website (in the Quiz section). The quizzes will cover the reading for that chapter. They must be completed <b>prior</b> to the start of that chapter's class. RQ will be due either on Tuesdays or Thursdays depending on when a given chapter begins.		
The online submission window will close one hour prior to the start of that chapter's first class (1:30 PM). The answers for each RQ are available one day after that RQ closes. There will be 10 RQs throughout the semester; the lowest graded RQ will be dropped from each student's overall grade.		
Random Discussion Assignment (RDA): 2% each; 5 RDAs; 4 RDAs graded.		
Randomly throughout the semester students will be asked to discuss and consider a question from the class discussion or weekly readings. Students will submit a brief written answer (after in class peer discussion) on the topic to the appropriate D2L space.		8%
Students will not know the dates of the RDA. Five RDAs will occur (worth 2% each) throughout the semester. The four highest scoring RDAs will count towards the final grade. The scoring system will be simple: complete (100%); incomplete (0%). Attendance will be taken on the days RDAs occur. In Class Short Essays (ICSE): 20% per ICSE		
dents will write three ICSE during the semester. These essays will be written in class on the gnated days. Student attendance on those days is required.		
A selection of four questions will be posted at the beginning of each module. On the day of the inclass exam, only two questions (from the original four) will be available to answer. Students will select one of the two questions. Students will have approximately 75 minutes to write their answer. In Class Short Essay Final (ICSEF): 20%  A final short essay will be written on December 7. Like the previous ICSEs, students will know in advance the four topics in advance. From the four, two questions will be available on the day of the ICSEF; students will answer one of the two questions.  The potential questions will examine the course as a whole. That is, the questions will draw from themes covered since the beginning of the semester. The questions will be finalized within the ICSEF prep session. Students will be compose an essay of approximately 500 words in length. For more information, see the D2L content page.		20%
