CALENDAR DESCRIPTION

Restricted to students in Practical Nursing

This introductory course provides learners with the foundations of disease and illness across the lifespan. Learners will gain an understanding of pathophysiological alterations of body systems. Nursing management of disease and illness across the lifespan with an emphasis on interventions and treatment is also discussed. Cultural diversity in healing practices is explored as well as the incorporation of evidenced informed practice.

- f) explain compensatory and decompensatory mechanisms.
- g) describe chronic versus acute illness in the context of disease (health continuum and disease versus illness).
- h) identify the nursing management of disease and illness for body systems across the lifespan.
- i) identify holistic and traditional healing practices associated with common illness.
- j) define the influence of culture in health and healing.
- k) identify appropriate evidence informed research and practice resources.
