CALENDAR DESCRIPTION

This introductory course on abnormal psychology includes a modern integration of theoretical perspectives, classification of psychological disorders, specific disorders (anxiety, mood, sexual, schizophrenia, personality, substance-abuse related), assessment, and treatment methods. Students have access to study material and exercises via computers/internet.

6. Describe current models of cause and treatment for the following categories of mental disorders: anxiety, somatoform, eating, mood, schizophrenic, substance-abuse, personality, sexual and gender disorders.

7. Identify key concepts in the field of health psychology and psycho-neuro-immunology.

8. Describe the relationship between the field of abnormal psychology (psychopathology) and the Canadian legal and criminal justice systems.

COURSE GUIDELINES & EXPECTATIONS

Examinations and Quizzes:

There is 1 midterm examination in this course. It is comprised of multiple choice questions, T/F questions, matching questions, and short answer/fill in the blank questions. The midterm may also include questions **based on class activities and exercises**. The midterm is worth 25% of the final grade.

There are six quizzes in the course. There are no make-up quizzes. *Students who miss a quiz need to communicate with the instructor before the next class.* Quizzes are based on specific chapters. The best five of six quiz marks will make up 25% of the final grade. Students are encouraged to take advantage of practice quizzes available online from the text publisher.

Labs:

There are four labs in the course. *Two group labs and two individual labs.* All four labs count toward your final grade. Labs are due at the beginning of the class on assigned due dates. Labs need to be typewritten and should be approximately 750 words in length. Some class time will be set aside for students to work on their labs.

Final Paper: 2500-3000 words; APA. This is an academic/research-based paper on a topic of your choice. The paper is due during the first week of final exams but it may be submitted before the due date. Students will also provide a 5 minute presentation to the class in which they provide an overview of their research.

While students may send an electronic copy of a lab or final paper to meet a deadline, <u>a hard copy is required</u> <u>for marking purposes</u>. Late assignments will be penalized 3% per day. Assignments submitted more than a week after the due date will not be accepted unless there is a documented reason for the late submission.

Participation

5% Participation mark is based on:

- attendance
- attentiveness in class
- respectful behavior and conduct toward others and being mindful of the shared learning environment
- participation in class activities
- being prepared for class (doing course readings before class; D2L content)
