This introductory course on abnormal psychology includes a modern integration of theoretical perspectives, classification of psychological disorders, specific disorders (anxiety, mood, sexual, schizophrenia, personality, substance-abuse related), assessment, and treatment methods. Students have access to study material and exercises via computers/internet.

3. Explain the nature of the Diagnostic and Statistical Manual and the classification of mental disorders.

4. Describe procedures and methods of assessing mental health.

5.Describe current research methods used in the study of abnormal psychology.

6.Describe current models of cause and treatment for the following categories of mental disorders: anxiety, somatoform, eating, mood, schizophrenic, substance-abuse, personality, sexual and gender disorders.

7. Identify key concepts in the field of health psychology and psycho-neuro-immunology.

8.Describe the relationship between the field of abnormal psychology (psychopathology) and the Canadian legal and criminal justice systems.

COURSE GUIDELINES & EXPECTATIONS

LECTURE FORMAT:

This course will consist of lectures presented to you during the scheduled class times. PowerPoint slides and lecture notes will be posted to D2L before class; however, additional content may be discussed in class. Therefore, it is important that you attend class and take further notes.

ASSIGNED ARTICLES:

Throughout the semester, you will be assigned the following four articles to read:

- 1. Being Sane in Insane Places (Rosenhan, 1973).
- 2. The Phenomenology of Gender Dysphoria in Adults: A systematic review and meta-synthesis (Cooper et al., 2020).
- 3. Substance Related and Addictive Disorders (Suzuki & Kober, 2018).
- 4. The Science Behind the Academy for Eating Disorders' Nine Truths About Eating Disorders (Schaumberg et al., 2017).

Information from these articles will be tested on the subsequent exams (see course schedule).

EXAMS:

The exams may consist of multiple choice, true or false, and short-answer questions. You must write the exams during the scheduled class time in person. You must inform me before an exam if you cannot write it at the scheduled time. A make-up exam will only be scheduled if you can provide documentation for your absence. The exams will not be cumulative. Exam 4 will take place during the final exam period between April 15 and April 23.

PRACTICE EXAMS:

There will be four practice exams that must be completed online through D2L outside of class time. Practice exams will be due the night before each exam. The practice exams are open-book and there is no time limit for completing the practice exams. You will be allowed two attempts for each practice exam. Each practice exam will count towards two percent of your final grade ($4 \times 2\% = 8\%$). Practice exams may consist of multiple choice and true-or-false questions. Practice exams are noncumulative.

IN-CLASS ASSIGNMENTS:

There will be four in-class assignments required throughout the semester. Each in-class assignment will count towards four percent of your final grade ($4 \times 4\% = 16\%$). In-class assignments must be completed in class.

MOCK PATIENT INTERVIEWS:

During the semester you will be introduced to three mock patients during class. Your task will be to ask these 'patients' questions to determine the disorder(s) you think they are presenting with and to take notes. At the end of the interview, you will then submit your 'diagnosis' along with a brief write up of the symptoms presented by the mock patient that led you to that diagnosis. Each mock interview will count towards four percent of your final grade ($3 \times 4\% = 12\%$).
