2 Short Assignments: There will be two exercises to be completed within class with the purpose of practicing the skills and applying ideas of the course. In a supportive and safe learning environment, students will have the opportunity to work in pairs and/or groups of three. The first assignment is worth 10% and the second assignment will be worth 15%.	25%
Group Presentation: In teams of 2 to 3 students, groups will have the opportunity to select a topic of interest in counselling to share with the class. Presentation details will be discussed in class and guidelines will be provided on the course site.	20%
Quizzes: There will be 3 quizzes corresponding to information from the class, readings, and student presentations. Each quiz will be worth 15%. Quizzes will be multiple choice, true or false, and short answer style questions.	
Participation: Participation will be evaluated based on class attendance and quality of meaningful contributions in class. The emphasis is on the quality, not the quantity, of students' contributions in class. Quality contributions may include offering thoughtful comments on issues and theory, asking questions that advance the discussion, and building on the comments of others. Students will also complete short reflections and written activities related to lecture material. Active participation in the classroom exercises and

discussions fosters learning on both an experiential and cognitive level. This engagement enhances students' ability to apply their learning to personal and professional contexts. It is expected that students will participate actively and helpfully, with sensitivity to others, thereby contributing to a safe and supportive learning environment for all. Attendance is an important component of this course. If a student is absent, it is essential to contact the instructor promptly. Opportunities to complete missed work will be available within one week of the absence. Submissions after one week will be considered late and subject to a penalty of 10% per day.
