CALENDAR DESCRIPTION

This is an introductory course for students with little or no knowledge of Spanish. Students develop basic proficiency in oral expression, listening comprehension, reading, writing, and acquire a fundamental knowledge of grammar and vocabulary. Emphasis is on oral communication.

1. D2L activities – (15% of final grade)

Outside of class, you will complete online modules on our course D2L site to help you prepare for in-class speaking and listening practice, and to reinforce course concepts.

2. Listening assessments (5) – (20% of final grade)

Each chapter includes a listening quiz that consists of two parts:

1. Dictation: I will read questions aloud and ask you to write down what you hear and then answer the questions in writing.
2. Textbook audio recordings and videos: You will also answer written comprehension questions based on audio tracks and videos.

3. Presentations (2) – (10% of final grade)

On two occasions during the semester, you will give a short oral presentation to a small group of classmates and answer some questions orally.

4. Written tests (2) – (30% of final grade) (Examen A = 18%; Examen B = 12%)

You will complete two written tests that cover fundamental skills from the textbook chapters.

5. Participation – (10% of final grade)

Through guided activities in class you will have the opportunity to develop your speaking and listening skills. Attendance in class is essential and you are unlikely to be successful in the course or to become proficient in the language without being present and participating in class.

6. Final video (1) – (15% of final grade)

You will be asked to compile situations we practice in the classroom into a final video project that demonstrates your speaking mastery of course content.
