CALENDAR DESCRIPTION

In this course, students will design and create imaginary characters and costumes that can be used in comics, graphic novels, gaming, illustration, storyboards and animation. Through practical drawing exercises, students will learn to exaggerate, caricature, and cartoon to make their characters believable and give them personality.

- 1. Design both realistic and exaggerated characters from their imagination.
- 2. Produce drawings of their characters from memory at any angle.
- 3. Apply characters to visual storytelling for comics, graphic novels, storyboards, gaming, illustration and animation applications.

WEEK or DATE RANGE	ACTIVITY or TOPIC	OTHER NOTES
Week One Monday January 8, 2024	Lecture – Introduction to Character Design. Cartoon and caricatures in comics/television/gaming and illustrations. Cereal Mascots. Highlighting character designs that allow viewers to relate. Discussion of iconography in Scott McCloud's "Understanding Comics." Classwork – Taking inspiration from real life and photos, facial expressions, stylized self portraits in profile, straighton, and three-quarter view. Discussion of character traits/building a well-rounded character.	
Week Two Monday January 15, 2024	Lecture – Consistent design at all angles. Some popular and iconic characters such as Felix the Cat, The Simpsons, and Calvin and Hobbes visually dissected. The art of simplification. Classwork – Character Design Assignment	Assignment is due on February 5 th .
Week Three Monday January 22, 2024	Lecture – Expressions, expressions, expressions! How to depict different moods, attitudes, and subtleties in your character. Classwork – Identify the face muscles on iconic characters and deduce how best to emote them realistically.	
Week Four Monday January 29, 2024	Lecture – Resources to fast-track character design: Name and trait generators, prompts, roleplaying, 20 questions. Classwork – Students will design a roleplaying character of their choice and do a quick sketch of the completed character. They will get into groups and roleplay a conversation in a classroom.

Week Five Monday February 5, 2024	Lecture – Discussion of video game characters and their traits. Visual traits vs. digital personality. How to simplify traits into character dynamics. Classwork – Begin working on character interaction assignment. Team-up with another student's character perhaps?	Character design assignment due
Week Six Monday February 12, 2024	Lecture – Profiles of several artists and their approach to character design. Compare and contrast original character designs to their more refined final looks. Classwork – Work on the Character Interaction Assignment.	Please bring sculpting materials to NEXT class (in TWO weeks)
Week Seven Monday February 19, 2024	No class. Reading Week.	
Week Eight Monday February 26, 2024	Lecture – Sculpting with polymer clay, tools, properties, and the benefits of creating a 3-Dimentional mock-up of a character. Discussion about comic artists who make use of models in their comics. Classwork – Begin sculpture assignment.	Character Interaction Assignment due Please bring sculpting materials to this class.
Week Nine Monday March 4, 2024	Lecture – Stop-motion animation and what we can learn from the artform. Discussions of Nightmare Before Christmas, Coraline, King Kong, and Gumby. Classwork – Continue working on sculpture assignment.	Please bring sculpting materials to this class too.
Week Ten Monday March 11, 2024	Lecture – Side characters, one-dimensional characters – how to design them effectively and efficiently with maximum visual impact. Discussion of how creators have worked around having to design background characters in comics and anime. Classwork - 3-D Modelling introduction	Sculpture due.
Week Eleven Monday March 18, 2024	Lecture – Non-human characters and how to achieve a level of believability. Discussion of comics which feature animal/non-human characters like Bone, Pokemon, and Bojack Horseman. Classwork – Design inanimate object-based characters with two positive/neutral traits and one negative trait.	
Week Twelve Monday March 25, 2024	Lecture – Exaggerated character design and how to make it look balanced. Discussing Sergio Aragones' Groo the Wanderer and Hilda. Classwork – Adjust one of your characters to have exaggerated features or properties and discuss in class what positive or negative effects this has on the character.	3-D Modeled Character due.
Week Thirteen Monday April 1, 2024	No class – Easter Monday	
Week Fourteen Monday April 8, 2024	Lecture – The supernatural, the creepy, and the quirky. How to make something horrible into something loveable. Classwork – Pictionary and prep work for CCAF!	Sketchbooks due
