**Course outline**

Delivery mode: online group study  
Time: 35 hours  
Duration: Seven weeks  
Prerequisite: CLB 7 or above

**Overview**

This course is about learning how to ‘chat’ successfully in the workplace. The language and techniques presented in each lesson will help you build strong skills essential for communicating informally in the workplace.

There are six lessons in the course. Lessons one to five focus on developing your speaking and listening skills so you can communicate well to different people in different ways. Lesson one introduces small talk basics: why and where we make small talk, and choosing and practicing with appropriate topics. Lessons two and three focus on types of questions and techniques used for starting and keeping a conversation going. Lesson four looks at how to be a good listener. Lesson five teaches small talk ‘delaying’ techniques, body language and how to tell a story. All five lessons include practice exercises and quizzes for each of the topics and discussion board activities and assignments. They also contain practice exercises and quizzes that focus on developing the following skills: vocabulary, pronunciation, grammar and listening through dictation. In lesson six, you work on a number of tasks to consolidate and apply the skills you’ve learnt in lessons one to five.

**Learning Outcomes**

- express and respond to expressions of friendliness. (CLB 9)
- manage a conversation: use strategies to keep the conversation going, check comprehension, encourage participation. (CLB 8)

- maintain conversations by asking follow-up questions, confirming comprehension by repeating and summarizing. (CLB 7)
- tell an anecdotal story about a past event. (CLB 7, 8)

Temporary Grade	Description
I	<i>Incomplete:</i> A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress:</i> A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
