Students will use the basic rules of writing sentences and paragraphs. Students will develop reading comprehension and vocabulary and foster interest in reading. Students will accomplish life-long learning strategies and gain an understanding of Indigenous ways of knowing and world views. Students will practice learning skills for oral communication, critical thinking, social responsibilities, personal and cultural identity, and time and work management.

#### COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

This class will be in a classroom. It is a self-paced course, so students will be completing assignments at their own pace with the support of their instructor. Students will be introduced to the details of this format at the beginning of the course.

#### **EVALUATION OF LEARNING**

This course focuses on developing critical thinking skills to assess a range of readings. Students write and edit expository paragraphs using a variety of punctuation and grammatical structures. Students explore lifelong learning practices: goal setting, problem solving and internet searching. Students will build a portfolio of their work to be used as an evaluative tool in the assessment of their progress in the course.
