Students will use the basic rules of writing sentences and paragraphs. Students will develop reading comprehension and vocabulary and foster interest in reading. Students will accomplish life-long learning strategies and gain an understanding of Indigenous ways of knowing and world views. Students will practice learning skills for oral communication, critical thinking, social responsibilities, personal and cultural identity, and time and work management.

COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

This class is expected to be a combination of online, blended and in-person instruction. In person drop in class: Wednesday or Thursday 12:30-3:30pm; in person office appointment: Wednesday 9:00-12:00pm or by video chat/phone appointment arranged with instructor.

EVALUATION OF LEARNING

This course focuses on developing critical thinking skills to assess a range of readings. Students write and edit expository paragraphs using a variety of punctuation and grammatical structures. Students explore lifelong learning practices: goal setting, problem solving and internet searching. Students will build a portfolio of their work to be used as an evaluative tool in the assessment of their progress in the course.

This course uses the Competency Based Grading System on students' successful completion of the course learning outcomes.

COURSE GUIDELINES & EXPECTATIONS

This is a self-paced course. Students have the flexibility to follow an individually-adaptable timeline to complete the learning outcomes and assignments. The course is a combination of 6 online, blended and/or inperson hours per week with an expectation of studying another 4 hours per week. Students have a responsibility to work hard, attend class and/or meetings, and ask for support when needed.
