## 2. Intended Learning Outcomes

At the conclusion of this course each student will be able to:

- 1. Communicate understanding of the origins, development and evolution of past, current, and future criminological thought and discourse.
- 2. Describe, classify, evaluate and analyze the problem of crime, criminological theory and its contemporary application.
- 3. Use conceptual frameworks and paradigms to make independent interpretations and applications using criminal case studies.
- 4. Consider, interpret and evaluate the perspectives of other students with sensitivity to the values underpinning those perspectives.

#### 4. Course Content and Schedule

The content of this course is delivered through one weekly lecture lasting three hours. Course delivery may also include group discussions and other methods utilized at the instructor's discretion.

#### 1. Library Assignment:

The library assignment will be conducted by the college librarian during the first month of classes and will consist of exercises designed to familiarize the students with the Camosun College Library/Media Centre.

#### 2. Quizzes:

Quizzes will consist of multiple choice and true/false questions.

#### 3. Written Assignments: Journal Article Summaries (2):

Students are required to provide two separate summaries from articles appearing in scholarly journals. The summaries should be 1-2 pages in length and address a current issue, and/or, topic in criminological theory. One summary should originate from an electronic source and the other from the selection of journals in the library. Further discussion of the summary assignments will occur in class.

Assignments should be handed in complete with a cover page, which indicates:

- -title of your article
- -course number
- -instructor's name
- -date
- -references cited page
