CALENDAR DESCRIPTION:

An introduction to the fundamental principles of law; the development of law and legal institutions; the process of law reform; the structure and system of Canadian courts; the philosophy of Canadian jurisprudence; judicial law-making; and exercise of judicial power. (T)

Prerequisites: C+ in English 12 or assessment.

INTENDED LEARNING OUTCOMES

At the conclusion of this course each student will be able to summarize and demonstrate comprehension of fundamentals of Canadian law, the Canadian legal system and legal institutions; articulate the fundamental concepts of Canadian law, of the framework within which legislative and judicial authority are exercised, of the roles of lawyers and judges in the Canadian legal system, and of the concept of human rights; distinguish clearly between criminal and civil law; critically evaluate the strengths and weaknesses of the Canadian system of law and legal institutions.

EVALUATION:

Students will be evaluated according to the normal procedures and standards set by Camosun College. If exams or assignment deadlines are missed documentation of medical or legal problems will be required in order to write make-up exams or have assignment deadlines extended.

Marks will be determined on the basis of the following work:

1. First Examination- 15%

The first exam will be held in class on **February 8th**. It will consist of Fill-In-the-Blanks, Short Answers, and one Essay question. This examination will serve as a preview of the other examinations in this course and the level of performance expected in the course. The format of the three examinations will be similar and this preliminary examination should be used as a guide in evaluating the effort and skills required for successful completion of this course. A review and exam preparation session will be held in class on February 3rd.

2. Second Examination- 30%

A second examination will be given in class on **March 17th**. It will consist of three sections: Fill-In-the-Blanks, Short Answers, and Essay Questions. The exam will be based on material covered to date and will include material from lectures, discussions, and required readings. A review and exam preparation session will be held in class on March 15th.

3. Media Assignment- 15%

This assignment consists of collecting and annotating five articles from daily or weekly newspapers which show the relationship of criminal justice and the court system. A separate handout will be provided. The written portion of the assignment should be 500-750 words in length. The media assignment is due **March 29th**. Late assignments will be penalized. No assignments will be accepted after April 14th.

4. Final Examination- 40%

A final examination will be given during Final Examination Week, **April 18-26th**. The format will be the similar to the second examination. The exam will cover material presented in the course as a whole, though there will be extra emphasis on material presented since the second examination. A review and exam preparation session will be held in class on April 14th.

ORGANISATION OF THE COURSE:

This course is set up as a survey course taught through two lecture/seminar sessions per week. The course material is divided into three sections. The first will deal with the nature, sources and origins of law. The second section covers the role of legal institutions, including courts, judges, and lawyers. The third section will cover judicial decision-making practices and will introduce six areas of substantive law. All handouts and review sheets will be posted on the webpage for Crim 170.
