- (2 credits) W (2,1,0, .6)

MUS 140 continued: an ensemble of strings, winds, brass and percussion focusing on classic and contemporary literature for orchestra. Required for bowed string and harp majors. Woodwind, brass and percussion majors in Music Foundations and Music Diploma must take one or both of MUS 141 and 147: placement by audition.

Prerequisite(s): MUS 140 or MUS 146, or by placement audition with permission of the instructor.
