- O Demonstrate ability to vocalize and conduct simultaneously a brief (8 bars) prepared musical passage.
- O Demonstrate ability to read and transpose, to or from concert key, 8 bars of score written for a single standard orchestral transposing instrument.

4. Course Content and Schedule

Classroom , 1 hrs.; estimated out-of-class, 3 hrs per week Content:

- 1. Practise procedure: one or two students at a keyboard; others conduct patterns: four hand versions of symphonic repertoire: where possible, introduce ensembles
- 2. Aural and oral development at all stages of pattern skills on specific solfege exercises, incorporating various intervals, chromatics, enharmonics in ever increasing rhythmic complexity in four clefs.
- 3. Specific in-depth study of repertoire:
 - knowledge of string bowings and articulations
 - woodwind and brass articulations and tonguings
 - the human voice: vocal production: types---tessitura
- 4. Applied to scores and recordings of orchestral repertoire

5. Basis of Student Assessment (Weighting)
