# 2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

- 1. Describe conceptual approaches to art practice.
- 2. Effectively discuss and communicate one's informed opinion in relation to contemporary art practice.
- 3. Research and present ideas to groups on the subjects of contemporary art and theoretical practices.
- 4. Identify resources in the arts available to the arts community.

### **OVERALL OBJECTIVES**

This course will serve as a forum for 2<sup>nd</sup> year Visual Arts students to examine and discuss ideas and points of view that relate to issues in contemporary art and recent art history.

These ideas (topics) will be generated by gallery visits, required readings, quest artists/lecturers, videos and presentations by individual students.

## SPECIFIC OBJECTIVES

## Students will expand their abilities to:

- 1. Deal with art making as a conceptual as well as technical process.
- Support their studio activities with a more competent and confident ability to verbalize their thoughts, desires, and needs, by developing a vocabulary that is specific to the world of contemporary art.

- 3. Research and present new ideas, and their own ideas, to groups of people.
- 4. Communicate with other artists and art resource people In the community, i.e., curators, educational institutes, etc.
- 5. Understand and use the resources which advertise and present ongoing events in the visual arts.
- 6. Be flexible and tolerant when considering new and/or different ideas.

# Evaluation will be based on the following criteria:

# 1. Class Involvement and discussion 30%

This section is based on the quality of participation of the student. The student will be expected to attend every class session with 5% deducted for every missed meeting of the whole seminar or smaller group. This applies to classes missed without medical or unavoidable reasons (missing a bus does not count).

This section will also reflect the level of participation of the student in class discussion. This does not just refer to the act of talking, but also to the attention one pays to the speaker.

2. Notebook/Reviews 30%: Content-25%; Presentation-5% Students will be expected to keep a journal which will contain reviews of visiting artists, gallery exhibits, videos, readings, etc. This 30% breaks down as follows:

Each assignment will be 300–350 words and will be handed in at the beginning of the following class. It is important that they are handed in at this time because the class discussion on the topic will follow immediately. Failure to hand in on time will lead to an additional assignment on another topic.

# 3. Gallery Volunteer Work 5%

This is a practical work experience at an artist run centre. It will give the student an opportunity to both observe and participate in the events/functions that take place in that environment.

#### 4. Individual Seminar 35%: Content-25%: Presentation-10%

This section of the evaluation is the equivalent of the "Term Paper". The students will choose a subject that is of interest to themselves and is relevant to contemporary issues in the Visual Arts. The instructor will meet with the student well before the presentation date to discuss the topic and help the student plan a strategy for the research and preparation of the presentation. The written seminar will be handed in the day of the presentation. The presentation should last 15-30 minutes, with the balance of the hour devoted to discussion of the topic.
