### 5. Basis of Student Assessment (Weighting)

**Test Three** 

#### Presentation (10%)

December 4, 2005

Working cooperatively in pairs or threesomes, each student group will be prepared to lead a group discussion with the class focusing on the assigned readings. The group will be expected to summarize the readings assigned giving a critique of the content/methods of the research and facilitate a discussion with the class. **Each student will individually** be responsible for developing a discussion question which takes a provocative stance with respect to the materials being addressed.

### Test One – October 9<sup>th</sup> (20%)

The first test will be held October 9<sup>th</sup> in the first half of the class. The test will be based on the first five weeks of the course material (including assigned readings and lecture materials) and will consist of short question/answers and one short essay question.

### Test Two - November 6<sup>th</sup> (20%)

The second test will be held in class on November 6<sup>th</sup>. This test will be based on materials that fall under the course section entitled, "Representation, Subjectivity and the Sexual Division of Labour: From Barbie to Mummy" (including assigned readings and lecture materials). This test will consist of short questions/answers and one short essay question.

### Test Three – December 4<sup>th</sup> (20%)

The third test will be held in class on December 4<sup>th</sup> (final class). This test will be based on the last section of the course following Test Two (including assigned readings and lecture materials). The test will consist of short question/answers and one essay question.

Term Paper - due November 22<sup>nd</sup> (30%)

Each student is responsible for completing a four to six-page typewritten research paper that addresses one of the topics discussed in class. The student may take a broad look at a particular issue with respect to women's position in Canada or may take a more specific topic that addresses a case study of patriarchy. A list of suggested topics will be handed out inclass at the beginning of the second week of term.

Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. (For these courses a final grade will be assigned to either the 3 <sup>rd</sup> course attempt or at the point of course completion.)
