2. Intended Learning Outcomes

Upon completion of this course the student will expand on skills learned in ART 122 to be able to:

- 1. Outline the variety of materials and process choices available to the painter.
- 2. Exhibit skills in a variety of painting formats, including traditional and contemporary.
- 3. Analyze the use and effects of colour, contemporary and historical references, and social and political awareness in relation to painting.

3. Required Materials

From your drawing kit: Graphite, Charcoal, Conte, Pastels, Erasers, Masking tape, Glue stick, Sketchbook, Tool kit

New: Acrylic paints:

- 16 oz. titanium white
- 8 oz. yellow ochre, burnt sienna, burnt umber, iron oxide black, ultra blue, middle yellow, red, green, orange, and purple
- Brushes for use with acrylic paints

4. Course Content and Schedule

Here you will use acrylic paint as a core medium to explore the technical and expressive possibilities of paint: texture, color and surface. Historical and contemporary painting will play a large part in your course of study. Research and studio experimentation are equally important.

This course contains several demonstrations and projects in the classroom.

Assignments are given but open for interpretation and manipulation.

There will be 3 Class Critiques.

7 Assignments: objects, photographic sources, historical sources, figure + 2 open projects

Temporary Grade	Description
