2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

- 1. Communicate understanding of the origins, development and evolution of past, current, and future criminological thought and discourse.
- 2. Describe, classify, evaluate and analyze the problem of crime, criminological theory and its contemporary application.
- 3. Use conceptual frameworks and paradigms to make independent interpretations and applications using criminal case studies.
- 4. Consider, interpret and evaluate the perspectives of other students with sensitivity to the values underpinning those perspectives.

4. Course Content and Schedule

1. Attendance Policy

Students are expected to attend class regularly. Final grades may be reduced for more than <u>four unexcused absences</u> or the same number of incidents of <u>being</u> <u>late</u> to class. Please come to class on time. If you are not here when attendance is taken, the book will record you as absent.

2. Withdrawal Policy

Students should familiarize themselves with the withdrawal procedures of the college. If it becomes necessary for a student to withdraw from the class, he or she should do so at the earliest possible time. Be familiar with College deadlines associated with withdrawal policy. To prepare your written assignments for this course you are expected to cite all material taken from other sources using proper APA formatting. 5. Paper Deadline

All assignments will be collected immediately after attendance is taken in class on the due date. Papers not handed in at that time will be considered late – even if they are only 30 seconds late. Come to class on time.

Make a photocopy of your assignments to retain for yourself. If you choose not to retain a photocopy, you assume three significant risks; 1) if the assignment is lost and I have no evidence that you turned in a paper, you may receive the grade of F; 2) if a paper is lost and I have evidence that an assignment was turned in, you will

have to write another assignment; 3) if you must retype your assignment because of too many proofreading errors, you will have to resubmit your assignment.

Late Assignments

Instructor Policy Statement Exceptional and Unanticipated Circumstances

Temporary Grade	Description

Students are expected to attend all lectures and actively participate in class discussions. The lectures are **NOT** intended to review all the material upon which you will be examined. Therefore, independent reading is **crucial** for success in this course.

If circumstances arise that require a student to miss a scheduled lecture, it is the student's responsibility to inform the instructor of the reason(s) for their absence either prior to the class or as soon as possible. Students should be aware that a significant portion of the material covered in this course will be found exclusively in the lectures. Students are responsible for obtaining any missed notes from their colleagues and approaching their instructor (me) for any missed handouts.

Students are expected to arrive to class ON TIME and sign the attendance sheet at the start of the class. If a student is late for a class, it is the student's responsibility to notify the instructor that they were in fact present.
