4. Course Content and Schedule

Lecture/discussion topics range from ethics in criminal justice, offenders and mental health issues, sentencing, rehabilitation and programming, drugs and prison, peacemaking, restorative justice, and privatization of

prisons. The class runs from 11:30 to 2:20 on Tuesdays. Papers are due March 11 with group presentations starting on March 18. Quiz #1 is on Jan. 29, quiz #2 on Feb. 19 and quiz #3 on March 4. It is my hope to have at least one guest speaker in to talk to the class on Feb. 5 if possible.
