A continuation of MUS 146: a large ensemble of woodwinds, brass and percussion focusing on works of classic and contemporary literature. Classical woodwind, brass and percussion majors in Music Foundations and Music Diploma must take one or both of MUS 141 and MUS 147: assignment and placement by audition.

Prerequisite(s): MUS 140 or MUS 146; or by placement audition with permission of the instructor.
