## 5. Basis of Student Assessment (Weighting)

## 1. First Examination- 20%

The first exam will be held in class on **October 7th**. It will consist of Fill-In-the-Blanks, Short Answers, and Essay Questions. A review and exam preparation session will be held in class on October 2nd. The exam will cover material from lectures and required readings. This first examination will serve as a preview of the other examinations in this course and of the level of performance expected in the course.

## 2. Media Assignment- 20%

This assignment consists of collecting and annotating five articles from daily or weekly newspapers which show the relationship of criminal justice to parliamentary government. A separate handout will be provided for this assignment. The media assignment is due **October 28th**. Late assignments will be penalized. No assignments will be accepted after December 4th.

## 3. Second Examination- 30%

A second examination will be given in class on **November 6th**. The format will be very similar to the first exam. It will also consist of Fill-In-the-Blanks, Short Answers, and Essay Questions. The exam will be based on material covered since the first exam and will include material from lectures and required readings. A review and exam preparation session will be held in class on November 4th.

# 4. Final Examination- 30%

A final examination will be given during Final Examination Week, **December 8th-16th**. The format will be the similar to the previous examinations, though the final exam will be longer. The exam will cover material presented in the course as a whole, though there will be extra emphasis on material presented since the second exam. A review and exam preparation session will be held in class on December 4th.

#### **Temporary Grades**

Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.

IP	<i>In progress</i> : A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. (For these courses a final grade will be assigned to either the 3 <sup>rd</sup> course attempt or at the point of course completion.)
cw	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
