### **Description and overview:**

Demo teaching course is designed to offer practical experience in the art of teaching. All aspects of teaching are covered, including the teaching of technique, choosing suitable repertoire, interpretation from a practical and stylistic point of view, and managing a studio. Classes include lectures, teaching demonstrations, and discussion of the art of teaching. Students completing the Year Two Demo Teaching / Pedagogy II will have an increased knowledge of repertoire, vocal pedagogy, and a confidence in their teaching.

### **Course Organization**

The class will be scheduled on Wednesdays at 12:00 during first and second semester in Studio

303. The class will be taught in a lecture format. Students will be required to teach a “demo-lesson” that will be evaluated and graded by the instructor. The instructor will observe and grade the student’s ability in the following areas: how technique was instructed, keyboard skills of student teacher, quality of lesson including use of time and teaching technique, rapport with student and music value. There will be demo teaching schedule posted for students and contact info provided to enable the student teacher to work with the demo student prior to the in class lesson. Students will be required to write a research paper on pedagogy and or the art of teaching. There will be no final examination.

### **Course Evaluation**

In-class student demo lessons will be graded by the instructor throughout the semester. Each student will teach three (3) lessons per term. An accompanist will be provided for the class. Students should also consider making arrangements to rehearse with the official pianist to ensure an effective and polished presentation. The grades will reflect your ability to demonstrate that your work shows thoughtful attention to detail as conveyed in a competent presentation. Each student will complete a lesson plan prior to the class which will be submitted to the instructor prior to their in class demo lesson.

### **Vocal Literature Component:**

#### **Description and overview:**

This course will survey the essential works of the voice repertoire with regard to historical perspective, style and other themes.

#### **Course Organization**

The class will be scheduled on Wednesdays at 1:00 during first and second semester in Studio

304. The class will be taught in a lecture format combined with written materials and listening assignments. Students will be required to give in class presentations through the course of the program that will be evaluated and graded by the instructor. There will be a comprehensive examination including a listening test at the end of each semester. There will also be (3) listening tests through the semester.

#### **Marking Scheme**

Your in-class presentations will be graded by the instructor throughout the semester. Each student will present two presentations (2) per term. The grades will reflect you ability to discuss a topic of vocal literature with thoughtful attention to detail. Each student will comment on a topic and will provide written comments to the instructor at the time of the presentation. Students can opt to use recordings or ask friends to perform excerpts in the presentation “Live Performances” are welcome!
