Upon completion of this course the student will be able to:

- 1. Identify and describe fundamental philosophical problems, along with the classical philosophical answers to these problems.
- 2. Distinguish among various philosophical theories. Identify key periods and concepts in the (philosophical) history of ideas.
- 3. Critically analyze an argument philosophically by identifying its premise and conclusion and by assessing its strengths and weaknesses.

Philosophy: The love of wisdom

**Ethics**: A branch of philosophy that is concerned with concepts such as good and bad, right and wrong, correct and incorrect actions.

**Applied Ethics**: The attempt to apply theoretical ethics to real world problems.

**Business**: Commercial enterprise, profession, or trade operated for the purpose of earning a profit by providing a product or service; also called business enterprise. Entrepreneurs who put money at risk to promote a particular venture for the purpose of a profit create businesses. **Business (etymology):** O.E. *bisignisse* (Northumbrian) "care, anxiety," from *bisig* "careful, anxious, busy, occupied"

The content of this course will be to employ philosophical theory and critical thinking in detailed examination of short case studies that exemplify typical ethical problems faced by individuals working in the various aspects of the business world.

The objective of this course is to develop skills that enable you to understand and articulate ethical positions with respect to representative problems.

Temporary Grade	Description
--------------------	-------------

I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. (For these courses a final grade will be assigned to either the 3 <sup>rd</sup> course attempt or at the point of course completion.)
CW	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
